# WEBSITE AND APP TERMS OF USE

Effective as of 6.11.2018

#### IMPORTANT: PLEASE READ CAREFULLY

#### 1. AGREEMENT

- 1.1 The brand names "Zenka", "Zenka Finance" as well as their accompanying logo wherein used here, are owned by and are the intellectual property of Pata Mkopo Company Limited (a company incorporated under the laws of the Republic of Kenya with a company registration number PVT-LRUEVBV). All rights thereto are reserved.
- 1.2 By visiting or using any Pata Mkopo website, App, USSD service, portal or extranet ("Site"), or the services provided on any Pata Mkopo Site, you agree to these Terms of Use. If you are a Pata Mkopo customer, you are also bound by the Pata Mkopo Terms and Conditions of Loan Agreement and any other terms that apply to your loan or service. If any provision of these Terms of Use conflicts with any term in the Terms and Conditions, the Terms and Conditions apply.
