#### **COOKIE POLICY**

#### AT ZENKA FINANCE LIMITED

### WE TAKE YOUR PRIVACY AND YOUR TRUST IN USVERY SERIOUSLY.

- 1. DEFINITION
- 1.1 **App** means Zenka's mobile application;
- 1.2 **Cookie** means a small text file that we store on your computer or other electronic device, with your consent, when you access our website or you use our App. Cookies contain information that is transferred to your computer's hard drive.
- 1.3 **Policy** means this Cookie Policy;
- 1.4 **Services** means Zenka's Website and/or App.
- 1.5 **Website** means www.zenka.co.ke;
- 1.6 **Zenka** means Zenka Finance Limited with its registered seat in Nairobi Kenya.
- 2. BASIS AND SCOPE OF OUR POLICY
- The brand names "Zenka", "Zenka Finance", "Zenka Group" as well as their accompanying logo wherein used here, are owned by and are the intellectual property of Pocco SA. (a company incorporated under the laws of the Republic of Poland). All rights thereto are reserved.
- 2.2 This Policy provides you with information about how the Zenka uses Cookies, or, similar technologies, on our websites and applications and other services to enable us to understand how you interact with our products and services, to improve your experience, to allow you to use certain features, such as sharing content via social networks or other communications channels, and to help us remember your preferences they are solely intended to improve your user-experience.
- 2.3 This notice also provides information about how third parties may use such technologies in association with the operation of our Services.
- 3. ABOUT THIS COOKIENOTICE
- 3.1 This Cookie notice applies when you use any of our Services that refer or link to this notice. This notice may be supplemented by additional Cookie notices, or terms provided on certain areas of the Service or during our interactions with you.
- 3.2 With the exception to the Cookies that are set by third parties, Zenka and its affiliates which own or administer the Services, as identified therein, are the primary controller of your personal information provide to, or collected by or for, the Service.
- 3.3 There is a notice on our Website which describes how we use Cookies and which also provides a link to our Privacy Policy. If you use this Website after this notification has been displayed to you, we will assume that you consent to our use of cookies for the purposes described in this Policy and our Privacy Policy.
- 4. USE OF COOKIES BY ZENKA
- 4.1 Cookies are widely used in order to make websites and applications work, or work more efficiently, and help them remember certain information about you, either for the duration of your visit (using a

- "session" cookie erased each time you close your web browser); or for repeat visits (using a "persistent" cookie gets erased from your device after a predefined period of time; each persistent cookie will only be activated when you visit oursite).
- 4.2 Our Cookies allows us to provide you with increased website functionality and personalisation. To ensure that you can make full use of our Website and Apps, your browser will need to be set up to accept Cookies.
- 4.3 As detailed below, our use of Cookies may involve the collection and use of your information, such as internet protocol ("IP") addresses, or other online mobile identifiers. For more information on our collection and use of this information please refer to our Privacy Policy found <a href="here">here</a>.
- 4.4 The Cookies used on our website and Apps, are as follows:
  - (a) Strictly necessary cookies: these cookies do not store any personally identifiable information. However, they are essential in order to enable you to move around the website or Apps. They are usually only set in response to actions made by you which amount to a request for service, such as setting your privacy preferences, logging in or filling in forms. For instance, authentication and security Cookies are used to identify and recognise registered users and to enable them to gain access to requested content or features. You can set your browser to block or alert you about these Cookies, but without these Cookies, services you have asked for cannot be provided.
  - (b) <u>Functionality Cookies</u>: these cookies allow our website and Apps to remember the choices you make and your account preferences and to provide enhanced, more personal features. These are set by us or by our third party providers whose services we have added to our pages. For example, these Cookies will remember your log-in details. You can set your browser to block or alert you about these Cookies, but without these Cookies, services you have asked for cannot be provided.

  - (d) <u>Targeting Cookies</u>: these Cookies are set by us and our advertising partners to record your visit to the website, the pages you have visited and the links you have followed. We, and our advertising partners, will use this information to make the website, and, the advertising displayed to you more relevant to your interests. You can set your browser to block or alert you about these Cookies. Blocking these Cookies will not affect the Service provided you, but will limit the targeted advertising that you will see, or limit our ability to tailor the website experience to your needs.

- (g) Tracking Technologies including Pixels, Script, Web Beacons/Gifs, and Page Tags: these files, or, code may be included in our emails and Apps to record how you interact with us, to help us better analyse and improve our Services to you. Again, you can block the Cookies either through your browser or device settings, and these settings will apply to all Cookies whether included on websites or in emails. However, in some instances, depending on your email or browser settings, the files may be automatically accepted (for example, when you've added an email address to your address book or safe senders list).
- (h) <u>TrackingViaMobileApps</u>: When you use our mobile Apps, we may record information unique to you that are associated with your device (such as the device ID and IP address), your activity within the App, and, your network location. This information is used to measure and improve the performance of our App, to help us to know elements are the most and least popular, and, see how visitors move around the App itself. This helps us to improve the way the App works and improve user experience.

## 4.5. We use the following kind of cookies:

- a) Google Analytics- it uses cookies to help analyse how the website is being used. The
  information generated by the cookie about your use of the website (including your IP
  address) will be transmitted to and stored by Google;
- b) Session Cookies- they are automatically deleted when the browser is closed. They usually store an anonymous session ID allowing you to browse a website without having to log in to each page. They do not collect any information from your computer.
- c) Persistent cookies is one stored as a file on your computer, and it remains there when you close your web browser. The cookie can be read by the website that created it when you visit that website again.
- d) Recommend- the Website uses a product personalisation tool which uses cookies to help analyse the products being viewed and bought. The information generated by the cookie will be used to provide a more personalised product offering to you.
